

# **TERMS AND CONDITIONS – SPIN TO WIN**

## 1. Promoter name and address

Country Garden Mambourin Pty Ltd (ABN 87 620 145 039) trading as Windermere Mambourin of 275 Greens Road, Mambourin, VIC, 3024.

## 2. Who may enter

Only residents of Australia (Participant) are eligible for the Promotion. Participants under 18 years of age must obtain the prior permission of a parent or guardian over the age of 18 years to enter the Promotion, evidenced by the parent or guardian signing the registration form.

The following persons are ineligible to enter the Promotion:

- employees of the Promoter;
- parties to whom the Promoter has contracted work in relation to the Promotion;
- · parties who are otherwise directly involved with this Promotion; or
- any immediate family member of the above-mentioned parties.
